ORDER:

In the reference 1st read above, an action plan under USEP has been prepared with the target of 8095 and the same was communicated to all the Project Directors, DPMU to implement the USEP in all ULBs including new ULBs for the year 2012-13. Further, certain districts have been allotted addl target, totaling 10,000 was fixed for the year 2012-13.and the same was communicated to the DPMUs vide reference 2nd read above.

An amount of Rs.17,95,13,125/- have been released so far to the DPMUs & Mission cities towards subsidy for grounding the units for the year 2012-13.

In the references 3rd to 7th read above, certain Project Directors, DPMUs have requested to release budget to meet the required subsidy under USEP component

The proposals of the Project Directors, DPMUs of Adilabad, Krishna, Kurnool, Ongole & Warangal have been examined and decided to release the amount of Rs. 1,50,48,750/- (Rs One Crore fifty lakhs forty eight thousand seven hundred and fifty only) to the above said Districts towards advance subsidy under USEP as mentioned below:
