ORDER

As per the reference 1st read above detail guidelines has communicated to provide support to TLFs for social mobilization of PWDs for ensuring nurturing of CBOs of PWDs in all ULBs. Accordingly as per the reference 3rd read above 153 TLFs have passed the resolution for utilization of services of PWD Volunteers for strengthening of SHGs of PWDs.

Release of funds- PD MEPMA is requested to follow the guidelines for social mobilization of SHGs of PWDs as explained above. And separate funds are being released to PD MEPMA from UCDN Component of Capacity Building of CBOs –PWDs of SJSRY (as per the enclosed Annexure).

Hence sanction is hereby accorded for release of an amount of Rs 28,91700 (Rs twenty eight lakhs ninety one thousand seven hundred only) under UCDN Component of Capacity Building of CBOs –PWDs of SJSRY towards support fund for PWDs to TLFs for utilizing the services of Volunteers towards SHGs strengthening.


