The attention of all the Municipal Commissioners in the state is invited to the references cited.

- 2. Accordingly, vide ref 3rd cited, an amount of Rs. 45/- was fixed for the street vendors to pay to CSCs (Mee seva, e Seva, etc) or SHGs/ Resource persons or active member of SLFs/ TLFs for utilizing their services if required, for completing the data entry in various fields of Loan Application Form and uploading the relevant documents through online Web portal/ Mobile Application under PM SVANidhi.
- 3. Further, vide ref 4rd cited, in addition to the above facility, it has now been decided to allow CSCs to fill online Letter of Recommendation (LoR) application for street vendors who were not identified during survey and willing to take PMSVANidhi benefits, by charging Rs. 30/plus applicable taxes per vendor.
- 4. In view of the above, an amount of Rs. 30/- plus applicable taxes per vendor is fixed for the street vendors to pay to CSCs (Mee seva, e Seva, etc) or SHGs/ Resource persons or active member of SLFs/ TLFs for utilizing their services if required, for completing the data entry of Letter of Recommendation (for vendors who were not identified during survey) and uploading the relevant documents in PMSVANidhi portal. However, the Street Vendors can also utilize the services of Citizen Service Centers of Municipalities for the above said purpose for free of cost.
- 5. A separate register has to be maintained by all the members who are collecting the user fee from street vendors with the details of street vendors and signature/ thumb impression of street vendor for future purpose. The same has to be informed to all the street vendors in the municipality through Town Vending Committee.

It is therefore requested to take necessary action in the matter.
