ORDER:

In the ref.1st cited detailed guidelines were communicated from GOI regarding sanction of Revolving fund to SHGs and their federatic is. As per the guidelines, GOI provided one time revolving fund support of Rs 10000/ to each SHG, which have not availed such support earlier., which would form part of the corpus along with their own savings and also be utilized towards internal lending arrong its members with interest leveled based on the decision of SHG.

In this connection it is decided to release the Revolving Fund(RF) to newly formed SHGs for the year 2015-16 by following the eligibility criteria and Process (enclosed in – Annexure- II) to avail RF to SHGs and also where targets of SHG formation are achieved more than 100% in the year 2014-15.

In the reference 5th to 10th cited above, the Project Directors, MEPMA, Ranga Reddy, Mahabubnagar, Adilabad, Karimnagar, Nizamabad, and Medak districts submitted the proposals of Revolving Fund (RF) to 432 excess SHC in the year 2014-15 and the newly formed 681 SHGs in 2015-16

Eighty four Lakhs thirty Thousand only) towards release of Revolving Fund to 783 SHGs which are excess SHGs formed in 2014-15 and newly formed SHGs in 2015-16 to the concern Project Directors, MEPMA, DPMU as the districts mentioned in the tables above.

Hence, the Finance Manager, MEPMA is requested to release an amount of Rs.84,30,000/-(Rupees. Eighty four Lakhs thirty Thousand only) towards release of Revolving Fund to SHGs to the concern Project Directors, MEPMA, DPMU as per the above statements.
