- Further, while developing the credit budget for the year 2021-22 and strengthening of PWDs you are directed to consider the following items:
 - 1. Coverage of eligible SHGs of PWD for access of Bank linkage in all the clusters of COs.
 - 2. Should arrive CO wise, Bank wise, Town wise linkage for SHGs of PWDs.
 - **3.** A Minimum 3 % of Bank Linkage & SEP target should be earned for SHGs of PWDs in the credit Budget 2021-22.
 - **4.** Revival of the Default SHGs of PWD and arrived the target for formation of new groups of SHGs of PWDs on par with 3% SHGs of existing Women SHGs in all the ULBs.
 - **5.** Inclusion of SHGs of PWDs in all the SLF meetings and to be prepare the separate action Plan on SHGs of PWDs in the prescribed format.
 - 6. Capacity Building trainings to be conducted to all the SHG Group leaders of PWDs & EC & OB members of TVS duly following the guidelines on Book keeping by the concern COs and RPs of CBOs.
