With reference to the subject cited, third party survey of homeless was conducted in all ULBs during Feb to July 2018 by V Max e Solutions India Pvt. Ltd and identified 4,148 Homeless in 74 ULBs of Telangana State.

Through the reference 2nd cited, the Mission Director, MEPMA has instructed to re-verify the no. of homeless in ULBs where less than 10 homeless are identified and ascertain the actual no. of homeless by conducting the survey of homeless in all potential locations in ULBs in coordination with concerned MC, Sanitation staff, RPs and MEPMA staff.

Through the reference 3rd cited, the SMCs are allotted the Districts to perform field visit and monitor the progress of all MEPMA activities.

In view of the above, the SMCs are hereby allotted the following ULBs to conduct the survey of homeless and submit the report on actual no. of homeless identified.
