**ORDER:**

In the reference 1<sup>st</sup> and 2<sup>nd</sup> cited, detailed guidelines are communicated for sanction of RF to SHGs of PWDs under NULM and its utilization. Basing on the proposals and Bank pass books furnished by Project Directors, MEPMA, Nalgonda and Nizamabad districts sanction is accorded for payment of **Rs. 3,50,000** (Rupees. Three Lakhs Fifty Thousand Only) from SM & ID component of NULM. The details are enclosed:

It was proposed to release Revolving Fund to SHGs of PWDs and approved the same vide reference 2<sup>nd</sup> cited of Telangana state. Now, it is proposed to release RF to SHGs of PWDs only in 15 NULM towns.

Hence as per the above details, sanction has been accorded for release of Revolving fund (RF) to SHGs of PWDs @ maximum 10,000/- as the SHGs of PWDs must have minimum corpus fund and their must be every month transactions made till the date of proposals send its functional for the period of 6months from the date of formation with at least 5 SHG members.

Further, the Project Directors are informed that, the amount should be released to the SHGs of PWDs immediately without fail as per the guidelines communicated mentioned below.

1. PD should draft a circular in Telugu regarding utilization of RF and handover to the president, TLF before release of funds to the ULBs with a copy to Mission Director, MEPMA, Hyderabad.

2. PD, MEPMA will issue proceedings with the approval of the District Collector, for releasing the amount as per eligibility along with updated online information in favour of the TVSS through online transfer. The Project Director should not release amount without online updation of SHGs of PWDs and duly scrutinizing with earlier releases.

3. The respective PDs are also instructed to ensure that, the above funds would fulfill the SC/ST Sub- plan and furnish the particulars of % of SC, ST beneficiaries benefited through above funds in the following proforma along with U.C.

4. Town Vikalangula Samakyas resource persons (TVS RPs)/Community organizers would be trained in utilization of CEF/RF fund. Proper utilization will enable the TVSSs to access further financial assistance in the form of Bank loan etc., in future.

5. A public function duly inviting public representatives can also be held for inviting all the TTLFs/TVSSs to explain the concept of Revolving Fund and its proper utilization as per the guidelines communicated vide ref.2<sup>nd</sup> cited above.

Hence, the Project Directors of Nalgonda & Nizamabad districts is requested to meet the expenditure from the available funds. An amount of Rs. 1,30,000/-to Nalgonda district ( Rupees One Lakh Thirty Thousand only), Rs. 2,20,000 /-(Rupees Two Lakhs Twenty Thousand only) to Nizamabad district towards Revolving Fund to SHGs of PWDs respectively.

The above funds are released through concerned TLFs and UCs may be submitted immediately to the Head Office.

The expenditure shall be met from available funds of SM & ID component of NULM funds.
