Vide reference 1st and 2nd cited, the Mission Director, MEPMA has sanctioned and released amount towards establishment of Shelters for Urban Homeless in various ULBs of all Districts including erst while districts of Karimnagar and Nalgonda to Project Directors of Nalgonda and Karimnagar with instructions to transfer the funds to the Municipal Commissioners of concerned ULBs.

Further, the Project Director, Karimnagar District is requested to transfer the amount released under Shelter for Urban Homeless to Jagityal ULB to Project Director cum Municipal Commissioner, MEPMA, Jagityal District as shown in the above table.

Further, the Municipal Commissioners of Nalgonda, Miryalguda, Suryapet and Jagityal ULBs are requested to complete Construction / Refurbishment of Shelter for Urban Homeless immediately and ensure smooth functioning of shelters with all Basic amenities and submit the Utilization Certificates to this office for further releases.
