As per the ref 5<sup>th</sup> cited that all PDs are requested to ground the Generic medicine Pharmacy stores in all ULBs, But as per the record only four ULBs of Kurnool, Jammalamadugu of Kadapa District and Kothagudem of Khammam and Kapra Circle of GHMC grounded Generic Pharmacy units are grounded.

In this connection, Project Directors (IKP-URBAN) are directed to ground the Generic medicine Pharmacy units by SLFs/ TLFs/TVS through District Collector approval in all the Municipal Corporations By 31<sup>st</sup> August 2013 by following the process

- Identify the SHGs/CRPS/SLFS/TLFs/TVS who are having related B-Pharmacy and D-Pharmacy qualification certificates to open Generic medicine Pharmacy Stores in all Municipal Corporations.
- Collect the Application on above said unit through SLF/TLF resolution.
- Collector Approval: -Submit the Proposal to District Collector requesting for approval of grounding the units in the premises of District Hospital/ Area Hospital/ Urban Health Centers at free of cost.

- funding from USEP or UWSP as per the requirement.
- **Drug License**: Shall obtain retail drug licenses from Drug Control Administration before starting the stores.
- Shall appoint registered pharmacist and other staff install computer with suitable software for issue of sale bills.
- Shall use the list of drugs suppliers and rates of Jeevanadhara Pharmacy of Osmania General Hospital Hyderabad as a guideline for procurement unit a proper system is established.

Therefore, the Project Director, MEPMA and the Municipal Commissioners of the respective Districts are requested to take this task on special drive on grounding of Generic medicine Pharmacy stores by SLFs/TLFs/TVSs in the name of Jeevana Dhara Unit, duly utilizing the available subsidy under USEP & UWSP component and complete the grounding by 31<sup>st</sup> August 2013.
