ORDERS:

In the reference 3rd cited above the Project Director, Nalgonda district submitted the proposals for release of support fund towards Social Mobilisation activities in NULM towns.

In the reference 2nd cited, It is resolved in the 12th EC at agenda No.9 to provide support fund to TLFs / SLFs for strengthening of the SHGs of PWDs at ULB level through PWD Volunteers / Cluster Level Resource Persons (Disability) to facilitate the PWD groups in all aspects of services monitoring the functioning of SHGs of PWDs. Therefore the PWD Volunteer are also called as the Cluster Level Resource Persons (Disability).

In the reference 1st cited above, as per the guidelines of NULM it is decided to conduct the trainings only in NULM towns. The other towns which are under Non-NULM and the budget not received till now in Non-NULM towns are instructed to continue the PWD Volunteers till order issued from the Head Office of MEPMA.

In the reference 4th cited above the Mission Director, MEPMA has instructed the Municipal Commissioners of Non-NULM towns to take necessary action to allocate the funds from Municipal General funds towards resource fees to Cluster Level Resource Persons (CLRPs) & PWD Volunteers through Town Level Federations of Concern Urban Local Bodies.

In this regard, the funds towards trainings under sub component of Social Mobilization and Institutional Development (SM & ID) is released only for NULM towns in Nalgonda district
