**ORDER:**

In the reference cited above, an action plan under RYK/STEP-UP has been prepared with the target of 73,410 and the same was communicated to all the Project Directors, DPMUs and the commissioners of GVMC & VMC to implement the RYK/STEP-UP for the year 2013-14 duly fixing 65,000 for total placement target.

Accordingly, the trainings are going on and amount has to be released to meet the expenditure towards trainings. Hence, it is decided to release the 1<sup>st</sup> installment of budget for the year 2013-14, an amount of Rs.3,42,00,000/- (Rs. three crore forty two lakh only) to meet expenditure for the trainings under RYK/STEP-UP to all the Project Directors, DPMUs and the Commissioners of GVMC & VMC.

Therefore, sanction is hereby accorded for payment of Rs.3,42,00,000/- (Rs. three crore forty two lakh only) to all the Project Directors, DPMUs and the Commissioners of GVMC & VMC for taking up placement linked skill trainings under RYK/STEP-UP for the year 2013-14.

The Finance Manager of this office is authorized to release an amount of Rs.3,42,00,000/- (Rs. three crore forty two lakh only) from the STEP-UP component of SJSRY and transfer the funds as shown below:
