Sub: MEPMA-DAY-NULM –SUH -COVID-19-Sanction - free food for the shelter residents of Urban Homeless DAY-NULM shelters Rs.100/- per day per person &, payment of funds from the available funds from the ULB -Reimbursement against the authentication bills in 13 ULBs including GHMC & precautionary-Measures against COVID -19—instructions issued —reg

I invite your kind attention to the subject cited, that as sensitive to plight of the Urban Homeless in coping with nationwide lockdown in the country to break the chain of the infection caused by the spread of the coronavirus, there is urgent an requirement of the support to the urban homeless persons as they may not have any available source of livelihood

Accordingly the Ministry of Housing and Urban Affairs has decided that during the period of nationwide lock down all the urban homeless available in DAY-NULM Shelters should be provided with three hygienically prepared meals a day. For this an amount up to Rs 100/- per homeless per day shall be incurred from the Mission funds (Central as well as State share) available with States/UTs in case of inadequacy of this amount of this local level, States/UTs may contribute additional funds from their own resources.

Further, directions shall be given to NGO of DAY-NULM shelters for maintaining cleanliness, person hygiene and provision of Sanitizers hand wash facilities mask in the shelters. Awareness need to be created among the residents of the shelters on preventive measures against COVID-19. And the fresh/ newly mobilized homeless/ vulnerable person, (if found ill) should be refer to the hospital for health checkup before their staying in the shelters for the urban homeless.

In this regard it is decided to provide free food for Shelter residents of DAY NULM shelters of 13 ULBs of Adilabad, Nizamabad, Khammam, Warangal, Nalgonda ,Miryalguda, Ramagundem, Siddipet, Mahabubnagar, Jagtial, Karimnagar, Suryapet and GHMC with 1115 Capacity of Urban Homeless . List of Functioning shelters as on date 28.03.2020 enclosed)

Therefore the additional Commissioner UCD GHMC and Project Directors MEPMA of concern Districts are requested to take necessary steps to provide the free food for shelter residents of DAY-NULM shelters by following the financial norms, the details are

- 1. With reference cited as per the GOI guidelines, it is proposed for sanction of Rs.100/- (Rupees One Hundred only) for free food per person per day of three hygienically prepared meals to the shelter residents of only to the Urban Homeless of DAY –NULM shelters not for the Special shelters for Patient attendants of DAY-NULM shelters and time being budget will be allocated from the available Urban Local Body General funds of the concern 13 ULBs and further amount will be reimburse by the MEPMA Head office SUH funds of DAY-NULM against the authentication bills submitted by the ULBs, by maintaining the daily attendance of the shelter residents in the DAY-NULM shelters, which is effect from the Date 28.03.2020.
- 2. It is proposed to pay the pending payments towards Operational & Maintenance (O & M) funds to the Shelter Management Agencies (SMAs)/NGO managing the DAY-NULM shelters in 13 ULBs and budget will be allocated from the available Urban Local Body (ULB) General funds of listed 13 ULBs including GHMC and further amount will be reimburse by MEPMA Head office SUH funds of DAY-NULM against the authentication bills submitted by the ULBs through duly attested by DPMU MEPMA.
