ORDER:

Through the reference 1st cited, the Ministry of HUPA, Government of India, has issued guidelines for establishing the Shelters for Urban Homeless in ULBs. Further, vide reference 2nd cited the Govt. of Telangana has constituted the Project Sanctioning Committee for approval of Proposals submitted by ULBs.

Vide reference 3rd cited, the Project Sanctioning Committee has approved 41 proposals (New Construction: 7, Refurbishment: 11 and for Only O&M cost: 19 Shelters). Accordingly, the Mission Director, MEPMA vide ref 4th cited has sanctioned funds for establishment of shelters to ULBs.
