- 5. I, therefore, request the Project Director, MEPMA, Warangal (U) District to handed over the CLC with infrastructure (purchased under 1st installment @3.00 Lakhs) which is partially functioning in GWMC premises maintaining by the Adarsha TLF to the Commissioner, GWMC immediately.
