ORDER:

Vide reference 1st cited, the GOI has given guidelines under NULM to establish City Livelihoods Centers (CLCs) in all ULBs of NULM towns. The concept of CLCs is to bridge the gap between demand and supply of the goods and services of the urban poor.

In this regard, Each CLC will be provided a non recurring grant of Rs. 10 Lakhs as untied funds and the amount will be released in 3 installments. The milestones for release of installments may be as follows

- > 1st installment 30% released by SULM to ULB within one week of the proposal, sanction order is approved
- > 2nd Installment 40% after the staff of CLC is recruited
- > 3rd Installment 30% will be released offer launch of CLCs.

Vide reference 2^{nd} & 3^{rd} cited, the proposals received from SangaReddy and Karimnagar districts for NULM towns have been examined and recommended for the release of 1^{st} Installment of 30% i.e an amount of Rs. 3,00,000/- to each City Livelihoods Centers(CLCs) in SangaReddy and Karimnagar districts.

Therefore sanction is hereby accorded for the payment of Rs.15,00,000/- Lakhs (Rupees Fifteen Lakhs only) toward establishment of City Livelihoods Centers (CLCs) in 5 above mentioned ULBs.

Hence, the Project Directors, SangaReddy, Nalgonda, Suryapet, Miryalguda and Karimnagar districts are requested to meet the expenditure of Rs. 3,00,000/-(Rupees. Three Lakhs Only) towards establishment of City Livelihoods Centers (CLCs) from the available funds of SM & ID component of NULM funds.

The expenditure shall be met from SM & ID component of NULM funds at DPMU units.
