Government of India has decided to implement Street Vending as one of the components under National Urban Livelihood Mission and issued guidelines accordingly. Recently Hon'ble Supreme Court has also ordered to form Town Vending Committees (TVC) to initiate the process of Street Vending policy implementation with in two months in the reference 7th cited. In this connection, it is to inform that vide 6th cited, detailed guidelines were already communicated to all Municipal Commissioners in the State to form Town Vending Committees and further the Project Directors of MEPMA are directed to follow-up of formation of Town Vending Committees before 10th of October, 2013 itself.

GoI has issued national Policy on Street vending and Supreme Court has passed following remarks in the judgment pertaining to formation of TVCs.

"A centre piece of this policy is the role of Town Vending Committee (henceforth referred to as TVC) to be constituted at City / Town level. A TVC shall be coordinated by a Convener who should be nominated by the Urban Local Body concerned. The Chairman of TVC will be the Commissioner / Chief Executive Officer of the concerned urban local body. The TVC will adopt a participatory approach and supervise the entire processes of planning, organization and regulation of street vending activities, thereby facilitating the implementation of this policy. Further, it will provide an institutional mechanism for due appreciation of the ground realities and harnessing of local knowledge for arriving at a consensus on critical issues of management of street vending activities. The TVC may constitute, in collaboration with the local authority, Ward Vending Committee to assist in the discharge of its functions".

The guidelines for formation of Town Vending Committees communicated already are herewith furnished for the ready reference to initiate further action to form TVCs.

Town Vending Committee:

Town Vending Committee (TVC) means the body constituted by an appropriate Government for protecting the livelihoods of street vendors while at the same time imposing reasonable restrictions, if necessary, for ensuring flow of traffic and for addressing concerns relating to Public health and Hygiene in the public interest.

- ULBs with less than 10.00 lakhs population may constitute Town Vending Committee at ULB level.
- ULB / Mission Cities with more than 10.00 lakhs population may constitute Zonal Vending Committee.

TVS Constitution:

 Commissioner of ULB or Representative to be the Chairperson for Zonal Vending Committee

Town Vending Committee to be headed by the Municipal Commissioner with representation of

- o 40% of members from street vending community (Federations and Associations)
- 20% from ULB and other Govt. Departments (Local authority, planning authority and police)
- o 10% representatives from Banks and Insurance companies
- o 10% elected members of ULB & Area Sabha representatives
- 10% from NGOs, Professional groups (Lawyers, Doctors, Town Planners and Architects) and representatives of Trade and Commerce & Scheduled Banks

Hence, you are requested to issue necessary instructions to the Municipal Commissioners for formation of Town Vending Committees in order to commence the implementation of National Street Vending Policy before 25 of October, 2013.

Early action in the matter is much appreciated.
