

Minutes of the review meeting held on 29-09-2015

The Mission Director, MEPMA has reviewed all the subjects with the MEPMA staff and representatives of APITCO, TCS and CGG and given the following instructions.

General:

- All SMCs shall be well prepared to come to the weekly review meeting.
- All SMCs shall prepare success stories documentation for the concerned subjects
(Action: All SMCs)

Health & Disability:

- Furnish the information on progress of Screening Camps' and results of Camps conducted, such as No. of persons attended for Screening, No. of persons required Surgery, arrangements made to conduct surgery to the needy persons etc.
- All surgery eligible cases to be attended on priority.
(Action: SMC- Health & Disability)

NUHM:

- List out all the information required to incorporate in the Base Maps.
- Follow-up action to be taken on the Trainings imparted to the field functionaries
- The printing of Modules and Guidelines on MAS to be completed within 15 days.
(Action: SMC- NUHM)

CB&T:

- Prepare the list of No. of COs and CLRP's ULB wise.
(Action: SMC – CB&T, AO)

Social Security:

- Contact SERP for the provision of data entry for the balance 2000 scholarships.
- The data of persons enrolled under PMSBY and PMJJY schemes from Banks and map with the SHG members' data (Aadhar card) to arrive the progress.
(Action: DMC – LH)

Social Mobilization & Institution Development (SM&ID):

- Conversion of VOs into SLFs to be completed by 30.09.2015
- DO Letters to be addressed to all PDs on the releases of Revolving Fund and Online updation.
- Designing of City Livelihood Centers (CLCs) to be finalized
- Arrive the CLCs to be established.
(Action: SMC – SM&ID)

Shelter for Urban Homeless:

- Temporary shelters running in rented buildings in Nalgonda, Suryapet, Miryalaguda, Adilabad and Sangareddy shall be shifted immediately into the available Government buildings
- Follow-up with the concerned Municipal Commissioners for construction of Shelters – get the date of construction started.

(Action: SMC – SUH)

Street Vending:

- Follow-up with the Municipal commissioners for issue of ID cards to the Street Vendors and issue of Vending Certificates.
- Individual Bank Accounts to be displayed in Web portal both for NULM and Non NULM ULB wise.
- Bank linkage to be provided to the CIGs formed.
- Warangal Street Vending Markets issue to be discussed with Commissioner.
- 5000 members to be given bank linkage by October 2015.
- Prepare action plan to impart training to the Street Vendors (Food Items) on Hygienic and Nutrition values – by Food Inspectors, Home Science Nutrition Specialists, Krishi Viganan Kendrams etc.

(Action: SMC – SV)

Employment through Skill Training & Placement (EST&P):

- Sort out the issue of available of few eligible candidates in certain batches for Assessment and Certification.
- Online reports to be ready by 01.10.2015.
- All Attendance problems to be sorted out immediately by circulate the file with full data, for the Assessment pending batches.
- Visit the DPMUS and discuss with PDs to resolve the Pending bills in the logins of DMCs and PDs.

(Action: SMC – EST&P)

Self Employment Program (SEP):

- The progress is very poor in Warangal, Adilabad, Nalgonda, Medak and Khammam.
- APITCO to start the grounding of the Units. A certificate from concerned PD to be obtained.
- Get the details of pending applications with banks, where documentation completed to link with MUDRA scheme.

(Action: DMC – SEP)

Bank Linkage:

- Monitor the progress in districts viz., Adilabad, Medak, Mahabubnagar and Nalgonda.
- Address a letter to all controllers of Non data sharing banks for data sharing
- 50% target to be achieved by end of Sept. 2015

(Action: SMC – BL)

MIS Issues:

- MPRs to be uploaded by concerned SMC/DMC
- Sort out the issues in data entry by ULBs for MPRs.

(Action: SMC – MIS and all SMCs)

Tour Programs:

- All SMCs to give Advance Tour Programs

(Action: All SMCs and AO)

Finance:

- The funds received back from districts shall be arrived component wise. Funds position to be updated by next meeting.
- Talk to the PDs and arrive the component wise requirement of funds by the districts.

(Action: FM and all SMCs)
