# Minutes of the Video Conference held on 25-05-2015 with Project Directors and Municipal Commissioners by C&DMA

## Individual Toilets & Swachh Telangana:

All the Project Directors and Commissioners are directed to take up the following steps for mobilization of GAP Funding (Rs. 6000/- or Rs. 12000/-) required for construction of individual toilets by SHG members.

## Step 1: SLF / TLF Meeting

To facilitate SLFs & TLFs of all the ULBs to conduct special meeting keeping agenda regarding mobilization of initial amount required for construction of individual toilets and repayment method by SHG members.

#### Step 2: Meeting with LDMs

The Project Directors and Commissioners of all ULBs are directed to conduct meeting with LDMs for sanction of the initial amount.

## Step 3: Arrangement for Initial Payment

For procurement of materials required for construction of individual toilets the required amount can be mobilized either from SHGs corpus or Streenidhi or Bank loan/ Bank Linkage by submitting undertaking by SHG members or Group.

### **Step 4: Repayment Mode:**

The amount will be repaid to SHG corpus of Streenidhi or Bank loan / Bank Linkage after receipt of the amount from the Government or can be deducted from the SHG account.

#### Vaddi Leni Runalu (VLR):

Project Director Warangal is directed to verify and send the Vaddi Leni Runalu (VLR) signed proceedings from January 2012 to March 2014 to MEPMA head office for release of VLR amount to SHG accounts.

## **Employment through Skill Training & Placement (EST&P):**

#### Bills pending in the logins of Project Directors:

Project Directors of Karimnagar, Warangal and Nalgonda to process the bills immediately as lot of bills are pending.

- Payments to be released to the Skill Training Partners without delay and as per the guidelines.
- To ensure quality of training programme, Project Directors & Commissioners are requested to visit the training centers to be necessary action at their end and submit the inspection report.

## Shelter for Urban Homeless (SUH):

First instalment of 40% out of the total cost approved by the Project Sanctioning Committee to be released to the Commissioners of the NULM towns immediately to start construction and refurbishment.

## Social Security:

- 1. Death claims pending since 2010 may be uploaded in call centers as the option is already provided for registration of claims.
- 2. Download the scholarships data for 2014-15 and collect the details from all the eligible students for uploading the details of students.
- 3. Take necessary steps to enroll all staff & SHG members before 31<sup>st</sup> May in new insurance schemes (PMSBY & PMJJBY).

## Internet Connection to Urban Poverty Alleviation (UPA) Cell:

All the commissioners are directed to provide the Internet Connection to the Urban Poverty Alleviation (UPA) cell to implement and update the data into the MEPMA website.
