**ORDER:**

In the reference 1<sup>st</sup> read above, an action plan under USEP has been prepared with the target of 8095 and the same was communicated to all the Project Directors, DPMU to implement the USEP in all ULBs including new ULBs for the year 2012-13.

In the reference 2<sup>nd</sup> cited, certain instructions were communicated for effective implementation of USEP component by grounding the units for the year 2012-13.

In the reference 3<sup>rd</sup> & 4<sup>th</sup> read above, budget of Rs.100.31 lakhs and Rs.357.25 lakhs have been released to the DPMUs & Mission cities towards subsidy for grounding the units for the year 2012-13.

As part of this, it is decided to release the amount of Rs.10,60,25,250/- (Rs Ten crore sixty lakh twenty five thousand and two hundred and fifty only) to the DPMUs and the Mission Cities i.e. GHMC, GVMC & VMC towards advance subsidy under USEP as mentioned in the annexure enclosed.

Therefore, sanction is hereby accorded for ~~payment~~ <sup>release</sup> of Rs.10,60,25,250/- (Rs Ten crore sixty lakh twenty five thousand and two hundred and fifty only) to the DPMUs and the Mission cities i.e. GHMC, GVMC & VMC towards subsidy under USEP for 2012-13.
