The attention of the Commissioner, GHMC and MCs of all the ULBs is invited to subject & reference cited, wherein the Director of (NULM-I), New Delhi has requested to direct the ULBs to conduct and organize camps on the following activities under DAY-NULM from 17.01.2022 to 31.01.2022 on the occasion of 75th anniversary of our independence to celebrate Azadi Ka Amrit Mahostav:

- i. **Job Melas**: Creating pathways for employment to youth: the ULBs will organize placement drives in collaboration with other stake holders like training partners, local industry/employers, NSDC nodal officials etc. to boost placement of skilled candidates.
- ii. Winter mobilization of Urban homeless shelters for Urban Homeless : ULBs will take special drives to ensure that Urban homeless are rescued and brought to shelters. Site-specific action will be undertaken for mobilization of homeless persons and arrangement of temporary shelters to avoid any mishap during ensuing winter with proper facilities like heating, bedding, sanitizers, hand wash, drinking water, toilets and other arrangements in compliance to shelters for Urban homeless (SUH) guidelines.
- iii. **Loan Melas to boost credit flow to the SHGs** : ULBs will undertake special campaign for resolution of pending Bank Linkage applications of SHGs. In the effort, relevant Banks should be involved. This campaign may also be used for mobilizing fresh applications from eligible SHGs and for getting these resolved.

Hence, the Commissioner, GHMC and Municipal Commissioners of all Urban Local Bodies are hereby requested to organize camps on the activities as mentioned above from 17^{th} January to 31^{st} January 2022 and to submit weekly report on 23.01.2022 & 31.12.2022 (in Annexure-I) duly following the COVID restrictions imposed by the competent authorities.
