I invite your attention to the subject cited. The Additional Commissioner, UCD, GHMC and Project Directors of DPMU, MEPMA of all Districts of Telangana are requested to submit the proposals through online (efms portal) for sanction of Revolving Fund to the SHGs and SLFs duly following the guidelines of DAY-NULM in their respective districts on or before 22nd September 2018 for taking further action in the matter.

Further, the Mission Director, MEPMA has released certain amount towards Revolving Fund (RF) to SHGs during the year 2014-15, 2015-16 and 2016-17 and instructed to release the amount to eligible SHGs / SLFs and update the status in MEPMA website. But, till now it is noticed that certain ULBs have not yet updated the particulars of RF amount released to SHGs / SLFs in the portal in-spite of reminders from this office. Due to non-updation of release particulars in MEPMA website, the ULBs were not given the login ids for further updation of eligible SHGs in online portal (efms) from the year 2017-18 onwards.
