ORDER:-

In the reference first read above, Government have established a Mission for Elimination of Poverty in Municipal Areas and also established the State, District and ULB level units for effective implementation of the MEPMA activities.

2. In the reference second read above, the Project Directors of MEPMA have requested this office to release funds to meet the expenditure towards salaries of District Level unit staff, remuneration to outsourced staff and other office expenses. In this regard it is stated that as per availability of funds under A & OE head 2<sup>nd</sup> quarter balance budget, of an amount of Rs.65,90,080/- under A & OE 311 Component has been released to all DPMUs vide reference 3<sup>rd</sup> cited.
