GoI has recognized the need for development of a National Information System and Knowledge base with focus on urban poverty for the purpose of planning, policy making project formulation, implementation, monitoring and review, especially in the areas of slum development, provision of basic services to the poor and affordable housing. Accordingly, National Building Organization, Ministry of Housing & Urban Poverty Alleviation had launched a new scheme called 'Urban Statistics for HR and Assessments' (USHA). Accordingly, guidelines were issued vide reference 1<sup>st</sup> cited to provide a one time grant in aid for development of Slum profile, Poverty profile & Livelihoods profile including socio economic surveys in all urban local bodies. Instructions were issued for conducting the survey in the towns with population more than 40,000 as per 2001 Census including IHSDP and BSUP cities of A.P vide ref. 2<sup>nd</sup> cited.


In this regard guidelines and instructions were issued and released Rs. 250.02 lakhs for 75 ULBs from the funds of USHA through concerned Project Directors IKP – URBAN. Vide reference

3<sup>rd</sup> cited and requested to complete the physical survey of slum profile, household profile, additional infrastructure and to upload the database in CGG website.

While reviewing the progress of survey under USHA, It is observed that the progress is very slow in many Municipalities. Hence, all the Municipal Commissioners where the survey under USHA is taken up are requested to take all the steps to complete the physical survey of Slum profile, Household profile and Additional infrastructure to upload the database in CGG website by 30-06-2013.

This item of work shall be attended on top priority, any slackness and delay in the above work will be viewed seriously and suitable action will be initiated.
