Attention to the sub. & refs. cited, the Under Secretary, MoHUA, GoI has informed that Hon'ble Parliamentary Standing Committee on Urban Development is reviewing the implementation of Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act 2014 and stated that natural/ heritage markets are not yet declared by considerable number of ULBs. In this regard, requested to take necessary steps to declare Natural/ Heritage Markets where street vendors were carrying out business for over Fifty years and street vendors in such markets may not be relocated as per Clause zb (viii) of the Second Schedule of Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act 2014.

Accordingly, the Commissioner, GHMC, CEO, SCB and MCs of all ULBs are requested to submit the list of Natural/ Heritage Markets where street vendors were carrying out business for over fifty years and to take necessary steps to notify Natural/ Heritage markets in concerned ULB. The list of Natural/ Heritage markets and their notification status may be submitted to undersigned immediately (Format enclosed at Annexure 1).
