
Accordingly as per the MOU between National Urban Health Mission (NUHM) & MEPMA, MEPMA is the development partner for implementation of community process of NUHM.

As on date total 2742 MAS has formed in 41 ULBs. In this regard it is proposed to release the untied fund @ 5000 per each MAS for the year 2016-2017. Accordingly submit the following documents as follows:
