<u>Pre-conditions for setting up of stalls:</u>

- MEPMA will provide the stalls to the SHGs with free of cost.
- Accommodation for the SHG participants provided near to SARAS exhibition premises only, with common Toilets and Bath room facilities.
- Project Directors of DPMUs shall issue ID cards to the participants.
- Transport arrangements have to be made by the participants (own arrangements) to reach Hyderabad by 11/12/2021 at 11:00AM to take over the allotted stalls.
- Participants can prepare their display boards in cloth banners for display at their stalls consists of SHG name, place/town, product name, promoted /supported by MEPMA etc.(Type design will be given by PD)
- Participants are instructed not to use plastic bags and alternatively use non woven bags.
- All the participants should follow Exhibition dress code.
