ORDER:

Through the references cited, the Government of Telangana has issued orders along with detailed guidelines regarding Pattana Pragathi Programme. Demarcation of street vending zones is a component under Pattana Pragathi programme in all ULBs. The Honble Minister for MA&UD, IT, Ind&C during the Pattana Pragathi in Mahabubnagar Municipality on 24.02.2020 directed to develop vending zones in ULBs. Accordingly, indicative guiding parameters for improvement of infrastructure and providing basic amenities in vending zones of street vendors under Pattana Pragathi were already communicated to all ULBs vide ref 7th cited.

2. The Project Sanctioning Committee has approved for construction of Street Vending Kiosks in Siddipet (45 No's) and Sircilla (53 No's) ULBs vide ref 2nd cited, and vide ref 4th cited, 1st Installment i.e., 40% of Total Project Cost was released to respective ULBs for construction of Street Vending Kiosks.

- 3. Further, the Project Sanctioning Committee vide ref 3^{rd} cited has approved for construction of Vegetable Markets (03 No's) in Siddipet ULB, and vide ref 5^{th} & 6^{th} cited, 1^{st} & 2^{nd} Installments (40%+40%) were released to Siddipet ULB.
- 4. In this connection, the MC&PD of Sircilla and Siddipet ULBs vide ref 8th,9th&10th cited have informed that the construction of kiosks/ vending markets is completed and submitted the Utilization Certificates for the amounts already released and requested for release of balance funds.
