Kind attention of the Commissioner, GHMC, CEO, SCB and MCs of all ULBs (except Kothur and Nakerekal) in the state is invited to the sub. and refs cited.

- 2. The instructions were issued to conduct Socio Economic Profiling (SEP) of Street Vendors and their family members and organize camps for grounding of schemes to the eligible beneficiaries in coordination with various line Departments vide ref 4th cited.
- 3. Further, vide ref 1st cited, the Director, PM SVANidhi, MoHUA, GoI has requested to organize SVANidhi se Samriddhi camps in February 2023, for ensuring scheme linkages to these beneficiaries as per the eligibility. The camps are to be organized with a caption of "Pattana Pragathi Street Vendor Development SVANidhi se Samriddhi"
- 4. District Level Committee to be organized before start of camps. The City Level Nodal Officers of line Departments (Labour welfare, Health and Family Welfare & Civil Supplies) and LDMs should attend the camps and sanction the schemes to the eligible beneficiaries and update the details in the portal. The ULBs should also update DLC meeting minutes and camp activity (Geo tagging) in SVANidhi Se Samriddhi mobile app.
