Kind attention of the Commissioner, GHMC and MCs of Selected ULBs (09 No's) in the state is invited to the subject and references cited.

- 2. The instructions were issued to conduct Socio Economic Profiling (SEP) of Street Vendors and their family members and organize camps for grounding of schemes to the eligible beneficiaries in coordination with various line Departments vide ref 4th cited.
- 3. Further, vide ref 1st cited, the Joint Secretary, MoHUA, GoI has requested to organize camps from 15th to 20th November 2021, for ensuring scheme linkages to these beneficiaries as per the eligibility. The camps are to be organized with a caption of "Pattana Pragathi SVANidhi se Samriddhi". Further, requested to utilize these camps for onboarding of Street Food Vendors on Swiggy & Zomato Platform.
- 4. District Level Committee meeting to be organized before start of camps. The City Level Nodal Officers of line Departments (Labour welfare, Health and Family Welfare & Civil Supplies) and LDMs should attend the camps and sanction the schemes to the eligible beneficiaries and update the details in the portal. The ULBs should also report camp activity on geo-tagging facility in SVANidhi Se Samriddhi mobile app.
