The attention of all the Municipal Commissioners in the state is invited to the references cited, and it is to inform that the detailed guidelines on PM Street Vendors AtmaNirbhar Nidhi (PM SVAN), a Special Micro Credit Facility to Street Vendors (SVs) were already communicated vide ref 2<sup>nd</sup> cited. As indicated in Para no. 9 of guidelines of PM Street Vendors AtmaNirbhar Nidhi (PM SVAN), since, the state of Telangana do not have presence of MFIs, the robust network of SHGs/SLFs/TLFs shall be utilized for mobilizing and generating the loan applications from street vendors through an online Web portal / mobile application, and requested states to device a suitable incentive mechanism for the SHGs.

- 2. Further, the Under Secretary, MoHUA, GoI vide ref 3<sup>rd</sup> cited have informed that the Loan Application Form (LAF) / the application for Letter of Recommendation (LoR) involves completing data entry in various fields apart from uploading the relevant documents, the individual Street Vendor may find difficult to complete the application process by self. Therefore, such vendors may seek services of Common Service Centers (CSCs), SHGs/ SLFs/ TLFs in Telangana State.
- 3. In view of the above, an amount of Rs. 45/- is fixed for the street vendors to pay to CSCs (Mee seva, e Seva, etc) or SHGs/ Resource persons or active member of SLFs/ TLFs for utilizing their services if required, for completing the data entry in various fields of Loan Application Form/ Letter of Recommendation and uploading the relevant documents through online Web portal/ Mobile Application under PM SVANidhi. However, the Street Vendors can also utilize the services of Citizen Service Centers of Municipalities for the above said purpose for free of cost.
- 4. A separate register has to be maintained by all the members who are collecting the user fee from street vendors with the details of street vendors and signature/ thumb impression of street vendor for future purpose. The Municipal Commissioner concerned has to verify the registers regularly. The information regarding the user charges shall be informed to all the

street vendors in the municipality through Town Vending Committee.

It is therefore requested to take necessary action in the matter.
