ORDER:

In the reference 1st cited, detailed guidelines are communicated for sanction of RF to SLFs under NULM and its utilization. Basing on the proposals and Bank pass books furnished by Project Directors, MEPMA, Adilabad district and the Additional Commissioner, UCD,GHMC circles vide reference 3rd & 4th cited sanction is accorded for payment of **Rs. 47,50,000** (Rupees Forty Seven Lakhs Fifty Thousand Only) from out of NULM component. The details are as follows:

It was proposed to release Revolving Fund to SLFs and approved the same in Action Plan 2014-15 of Telangana state. Now, it is proposed to release RF to SLFs of SHGs only in 15 NULM towns.

Hence as per the above details, sanction has been accorded for release of Revolving fund (RF) to the SLFs @ maximum 50,000/- to each proportionate to corpus available with SLF. The RF is given to both newly formed SHGs whose Corpus is not less than 50,000/- its functional for the period of 6 months with at least 70% of SHG members and also to the senior most SHGs who are not yet released any amounts previously following the seniority of their registration.

Further, the Project Directors are informed that amount should be released to the SLFs immediately without fail.

1. PD should draft a circular in Telugu regarding utilization of RF and handover to the president, before release of funds to the ULBs with a copy to Mission Director, MEPMA, Hyderabad.
2. PD, MEPMA will issue proceedings with the approval of the District Collector, for releasing the amount as per eligibility along with updated online information in favour of the SLFs through online transfer. The Project Director should not release amount without online updation of corpus and duly scrutinizing with earlier releases.
3. The respective PDs are also instructed to ensure that, the above funds would fulfill the SC/ST Sub- plan and furnish the particulars of % of SC, ST beneficiaries benefited through above funds in the following proforma along with U.C.

4. SLFs OBs & Slum level resource persons (SLF RPs)/Community organizers would be trained in utilization of CEF/RF fund. Proper utilization will enable the SLFs to access further financial assistance in form of Bank loan etc., in future.

5. A public function duly inviting public representatives can also be held for inviting all the SLFs to explain the concept of Revolving Fund and its proper utilization as per the guidelines communicated vide ref.1st cited above.

Hence, the Project Director Adilabad district is requested to met the expenditure of **Rs. 11,00,000/-** (Rupees Eleven Lakhs Only) towards CEF/RF to SLFs for NULM towns as per the proposal send from the available funds of SM & ID component of NULM funds.

The Project Director, Ranga Reddy district is directed to met the expenditure of **Rs. 36,50,000/-** (Rupees. Thirty Six Lakhs Fifty Thousand only) towards RF to SLFs of (Circle-01 Kapra & Circle-02 Uppal) of GHMC under SM & ID component of NULM. The expenditure shall be met from the available funds of GHMC at DPMU unit of Ranga Reddy District.

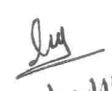
