Sub : MEPMA – Swachh Telangana Mission - Construction of Individual toilets through SHGs Corpus / Streenidhi /Bank loan / Bank Linkage and repayment through SHGs–Issue of Guidelines - Reg

Ref : 1. Swachh Bharat Mission Guidelines Issued by MoUD ,GOI.

With reference to subject cited it is to inform that for construction of Individual toilets, Government is sanctioning Rs 12,000/- in two installments. As per the guidelines first installment (Rs 6,000/-) will be given after completion of basement and second installment (Rs.6, 000/-) will be released after completion of the construction of individual toilets.

In this regard it is suggested that to meet the initial amount required for completion of basement work of the toilet by the SHG members the following strategy may be adopted, since the poorest of the poor might not have adequate funds to kick start the process.

Step-1: SLF/ TLF Meeting:

All SLFs are to be conducted Special meeting on Individual toilets by mobilizing all SHGs through drive mode and collect the information on Individual toilets and submit to the Municipal Commissioners for sanction of amount and they shall keep Special Agenda item regarding mobilization of initial amount required for construction of toilets and repayment method.

Step -2: Arrangement for initial amount:

For procurement of materials required for construction of individual toilets the required amount can be mobilized either from SHG corpus or Streenidhi or Bank loan / Bank Linkage by submitting undertaking by SHG members or Group.

Step -3: Repayment Mode:

The amount will be repaid to SHG corpus or Streenidhi or Bank loan / Bank Linkage after receipt of the amount from the Government or can be deducted from the SHG account. (The copy of undertaking by member of SHG or Group is enclosed) .

Therefore all the Project Directors are requested to take necessary steps for construction of individual toilets following the above mentioned process.
