Through the ref. 3<sup>rd</sup> cited, the District wise targets and amount of credit/loan to be disbursed by the banks are finalized and communicated along with the Timelines to be followed for implementation of Self Employment Programme activities.

Through the ref. 4<sup>th</sup> cited, the ULB wise progress status has been reported in MEPMA portal, which shows a large variation between the target and stage of progress shown.

The following lapses have been noticed in the implementation of SEP scheme in districts:

- The Joint Identification Camps have not conducted so far in all districts except Kothagudem.
- The DMCs performance is inadequate in SEP component.
- Repayment details were not updated for the loans disbursed in previous years in the screens provided in MEPMA portal.

You are aware that the 1<sup>st</sup> quarter of 2017-18 has gone by June 2017 and not even single unit has grounded except GHMC, Khammam, Mahabubnagar, Nalgonda, Suryapet and Yadadri districts which makes a negative remark on the State image at national level.

Hence, all the Project Directors of MEPMA in the state are directed to achieve 50% of the target in Self Employment Programme and SHG-Bank Linkage by 15<sup>th</sup> August 2017 by conducting Joint Identification Camps. Necessary action may be taken for distribution of loans to the SEP beneficiaries in the Independence Day Celebrations.
