ORDERS:

In the reference 1st cited above, as per the guidelines of DAY-NULM it is decided to conduct the trainings to PWD Volunteers.

In the reference 2nd cited, It is resolved in the 12th EC at agenda No.9 to provide support fund to TLFs / SLFs for strengthening of the SHGs of PWDs at ULB level through PWD Volunteers / Cluster Level Resource Persons (Disability) to facilitate the PWD groups in all aspects of services monitoring the functioning of SHGs of PWDs. Therefore the PWD Volunteer are also called as the Cluster Level Resource Persons (Disability).

In the reference 3rd to 5th cited above the Project Directors, Siddipet, Warangal & Mahabubnagar districts submitted the proposals for release of support funds towards Social Mobilization activities in NULM towns.

The Project Director, Siddipet requested to release from 01.01.2016 to 31.03.2017 so releasing the same therefore Husnabad ULB has been not released the funds till now as the funds released only in NULM towns. Now Husnabad ULB has also extended to DAY NULM town from 2016-2017 onwards .

Accordingly with reference 2nd cited it is proposed to release the Husnabad ULB from 01.04.2016 to 31.03.2017 .
