### **ORDER:**

Through the reference 1<sup>st</sup> cited, the Ministry of Housing & Urban Poverty Alleviation, Govt of India has issued guidelines for establishing the Shelters for Urban Homeless in NULM Towns.


The Project Sanctioning Committee vide reference 3<sup>rd</sup> cited has approved proposal for Refurbishment of Old Press Building, near Railway station in Nizamabad for establishment of Shelter for Urban Homeless with total project cost of Rs. 12.40 Lakhs. Accordingly, the Mission Director, MEPMA vide ref 4<sup>th</sup> cited has released an amount of Rs. 4.96 Lakhs towards 1<sup>st</sup> Instalment (40% of total project cost).

Further, the Municipal Commissioner, Nizamabad Corporation has completed the refurbishment works to Old Press Building and submitted the Utilization Certificate to the funds already released. In this regard, the Project Director, Nizamabad vide ref 6<sup>th</sup> cited has informed that the Municipal Commissioner, Nizamabad Corporation has completed the refurbishment works and requested to release an amount of Rs. 7.44 Lakhs towards balance funds 60% (40%, 2<sup>nd</sup> instalment + 20%, 3<sup>rd</sup> instalment) of total project cost.

Hence, sanction is hereby accorded for release of Rs. 7,44,000.00 (Rupees Seven Lakhs Forty Four Thousand only) to the Project Director, MEPMA, Nizamabad District towards balance funds (2<sup>nd</sup> & 3<sup>rd</sup> instalment) 60% of total project cost for Refurbishment of Shelter for Urban Homeless at Old Press Building, Near Railway Station, Nizamabad from SUH Component of DAY - NULM.

Further, the Project Director, MEPMA, Nizamabad District is directed to release the funds to the Municipal Commissioner, Nizamabad Municipal Corporation and submit the Utilization Certificate.

The Finance Manager, MEPMA is directed to release an amount of Rs. 7,44,000.00 (Rupees Seven Lakhs Forty Four Thousand only) to the Project Director, MEPMA, Nizamabad District through e transfer from the available funds under SUH component of DAY-NULM.
