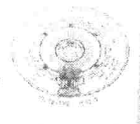

Over one billion people, or approximately 15 per cent of the world's population, live with some form of disability. Around the world, persons with disabilities face physical, social, economic and attitudinal barriers that exclude them from participating fully and effectively as equal members of society. They are disproportionately represented among the world's poorest, and lack equal access to basic resources, such as education, employment, healthcare and social and legal support systems, as well as have a higher rate of mortality. In spite of this situation, disability has remained largely invisible in the mainstream development agenda and its processes

International Day of Persons with Disabilities is annually observed on 3<sup>rd</sup> December with an objective to promote an awareness of disability issues, the fundamental rights of persons with disabilities and integration of persons with disabilities in the main stream of each aspect of the social, political, economic and cultural status of their communities. The day extends an opportunity to initialize action to reach the target of full and equal pleasure of human rights and contribution in society by disabled persons.

**World Disability Day's theme this year will be “Break barriers, open doors: for an inclusive society for all”**

On the occasion of World Disabled Day on 3<sup>rd</sup> Dec, 2013, MEPMA has decided to observe “World Disabled Day” celebrations with a view to secure wide coverage and disseminate the message to all the stake holders with the following list of indicative agenda at all District Head quarter ULBs covering all the TVSSs in the district.

- Invite Hon'ble Minister or District Collector as Chief Guest. MLAs and MPs and Special Officers and Municipal Commissioners of the ULBs may be invited to participate as Guests.

Disabilities from the all Town Vikalangula Samakhya (TVSs) and Parents Associations of Persons with Mental Retardation (PAPWMRs) in the district.

- Invite NGOs, service providers working in the field of Disability Rehabilitation and conduct of camp for distribution of free Aids & Appliances.
- Sharing the MEPMA's experiences in Empowerment of Persons With Disabilities Programme / success stories in the areas of Benefits of SHGs, Bank linkage, Assessment, Treatment & Rehabilitation, USEP (Self Employment), STEP-UP Jobs training candidates, NIRAMAYA Health insurance etc.,
- Organize exhibition stalls (both photo and Physical) for show casing the activities of SHG's Products, Assets created, Entrepreneurship, Aids & Appliances, Skill trainings, Self employment etc., by the SHGs of PWDs.(Action: DMC-Health & Disability)
- Organize singing and drawing competitions for Persons with Disabilities (Action: DMC-Health & Disability).
- Facilitate Bank linkages to eligible SHGs of Persons With Disabilities (Action: DMC-Bank linkage).
- Facilitate individual Bank Linkages for Persons with Disabilities under Urban Self Employment Programme (USEP). (Action: DMC-Bank linkage, Livelihoods DRPs & COs.)
- Mobilize the Aids & Appliances from the NGOs/Service Providers/donors/Philanthropists etc., and organize the distribution camp to distribute to the Persons with Disabilities (Action: DMC-Health & Disability).
- Distribution of NIRAMAYA Health insurance cards to the beneficiaries (Action: Speech by role models of person with disabilities and Felicitation of 3 role model Persons with Disabilities (PWDs) in the field of Disability (1 Women with Disability - Best entrepreneur, 1 girl pursuing professional education and 1 men with disabilities-best entrepreneur)..
- Initiating the construction of the Barrier free Environment features in the Municipal offices. (Action: Municipal Commissioners and Municipal Engineers of concerned ULBs).
- Organize medical-health check-up camps with the help of medical colleges, teaching hospitals, Nursing institutions etc., (Action: DMC-HD).
- Organize screening camps for Livelihoods under STEP-UP for starting one batch of exclusive Placement linked skill trainings for PWDs. (Action: DMC- Livelihood).

The above list is only indicative and the District Collectors / PDs / MCs may add any other items of importance of PWDs. Sanction is hereby accorded for Rs: 12,000/- (Twelve thousands) only per District towards conduct of the World Disability Day celebrations.

All the Project Directors, IKP-Urban and the Project Officers of GHMC, GVMC and VMC are requested to organize the World Disability Day celebrations on 3<sup>rd</sup> Dec, 2013 and send a report on programmes take-up on 3<sup>rd</sup> Dec, 2013 in the enclosed proforma on or before 4<sup>th</sup> Dec, 2013 to MEPMA.




