### ORDER :

In the ref.1<sup>st</sup> read above detailed guidelines were communicated for SM & ID under NULM , GOI regarding sanction of Revolving fund to SHGs and their federations. GOI will provide one time revolving fund support of Rs 10000/- to each SHG, which have not availed such support earlier, which would form part of the corpus along with their own savings and also be utilized towards internal lending among its members.

A SHG should be functional for a period of 6 months with at least 70% of SHG members should be urban poor to become eligible for Revolving Fund support under NULM . **The RF is also available to existing SHGs formed under SJSRY which have not availed the same.**

Accordingly with ref 2<sup>nd</sup> read above released the Revolving Fund( RF) to (Scheduled Tribes ) SC groups formed in SJSRY scheme formed in 15 NULM towns .

In this connection it is decided to revise the proceedings for release the Revolving Fund( RF) to (Scheduled Caste ) SC groups formed in SJSRY scheme formed in 15 NULM towns by following the eligibility criteria and Process (enclosed in -Annexure- II ).

Accordingly, the Project Directors of above districts are directed to release the funds for Revolving Fund to SHGs of SC (Scheduled Caste ) groups formed during SJSRY scheme duly following eligibility criteria, process and as per the online updation of the groups.( enclosed –Annexure - II)

The Project Directors shall furnish the details of sanctions to Mission Director, MEPMA & also update it online. It may be noted that if any discrepancy is noticed it will be treated seriously.

Therefore sanction is hereby accorded for the payment of Rs. 20880000-Rupees.( Two Crore eight Lakhs and eighty thousand only) towards release of Revolving Fund to 2088 SHG- SC (Scheduled Caste) groups formed in SJSRY scheme in 15 NULM towns .

Hence, the Finance Manager, MEPMA is requested to release an amount of Rs 20880000-Rupees.( Two Crore eight Lakhs and eighty thousand) only towards release of Revolving Fund to SC(Scheduled Caste ) groups SHGs formed in SJSRY scheme in 15 NULM towns to the concern Project Directors, MEPMA, DPMU as per the above statements.

The expenditure may be met from SM & ID of NULM funds.
