ORDER:

In exercise of the powers conferred under article 162 of the Constitution of India, and in consultation with the Advocate General for the State of Telangana, the Government hereby determines the remuneration payable, in respect of certain matters, to the Additional Advocate General, State of Telangana as follows:-

1. Retainer Fees	: Rs.25,000/- per month
2. Appearance in W.Ps, W.As, C.Cs, Contempt Appeals, Review cases, etc., including Habeas Corpus Writ Petitions	: Rs.5,000/- per appearance per case (not exceeding seven appearances in a day)
3. In respect of instrumentalities, other than Government, like Corporations, Universities, Local Bodies, companies, Societies, etc.,	: Rs.5,000/- per appearance per case (limited to seven appearances in a day)
4. (a) For settlement of Drafting of Civil Appeals including Land Acquisition Appeals and Arbitration cases CMAs & CRPs.	: (a) 1/3 rd of Fee calculated as per existing Rules and payable immediately after admission of the case.
(b) Arguing the above cases at various stages.	: (b) 2/3 rd of fee after disposal of the case.
5. (a) Fee payment in Supreme Court or other Courts at Delhi or other places.	: (a) As claimed by the Addl. A.G. and to be paid by the Department / Instrumentality concerned.
