The eligible data updated in NULM MIS will be forwarded to PAISA portal for verification and sanctioning of interest subvention. It is observed that the following ULBs are lagging behind i.e., below 60% in completion of online updation of Self Employment Programme (SEP), Bank Linkage (BL) even after lapse of 11 months in spite of continuous follow up as detailed below:

In view of the above, all the Municipal Commissioners and Project Directors of MEPMA in the State and the Addl. Further, the above poor performing ULBs are directed to expedite the updation and also directed to submit reasons for their poor performance within a week. Any slackness in this matter will be viewed very seriously and disciplinary action will be initiated against them whose performance is poor.
