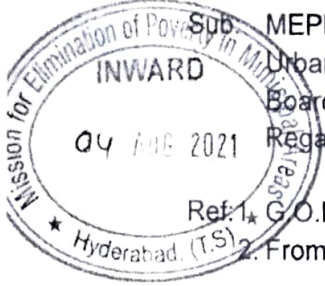

Minutes of the meeting held on 24.08.2018 by the Hon'ble M(MA&UD).

ORDER:

It is brought to the notice of Government that Resource Persons are working in Slum Level Federation, Town Level Federation and Town Vikalangula Samalkyas including Greater Hyderabad Municipal Corporation and these resource persons are engaged by Slum Level Federation / Town Level Federation and Town Vikalangula Samalkyas and each Resource Person is being paid Honorarium from the savings of Slum Level Federation / Town Level Federation and Town Vikalangula Samalkyas. These Resource Persons are assisting the Self Help Groups / Slum Level Federation / Town Level Federation for book keeping, facilitating bank linkages, Recovery of Loans, Participation in Telanganaku Haritaharam, Open Defecation Free (ODF), Swachh Telangana Flagship Programme etc. The representatives of the Resource Persons represented to Hon'ble M(MA&UD) to provide remuneration to them like in rural areas being paid to Village Organisation Assistants (VOAs) by SERP due to high cost of living in urban areas.

2. The Government after careful consideration hereby sanction honorarium @Rs.4000/- per month (Rupees Four Thousand only) per one Resource Person through Mission for Elimination of Poverty in Municipal Areas (MEPMA) in addition to the Honorarium paid by the concerned Slum Level Federation / Town Level Federation and Town Vikalangula Samalkyas. The Resource Persons shall continue discharging duties as allotted to them from time to time

3. The expenditure shall be met from Vaddilenti Runaalu and Streenidhi funds or any other source at the Greater Hyderabad Municipal Corporation/ Urban Local Body level.

4. These orders shall come into force with immediate effect.

5. This order does not require the concurrence of Finance Department.
