The attention of all the MCs in the state is invited to the references cited, and it is to inform that instructions were issued regarding **Community Based Recovery Mechanism** for regular repayment of Street Vendor loans by

- Formation of Common Interest Groups of Street Vendors (SVs)
- Mapping of SVs to concerned SLFs
- Capturing the repayment status of SV loans and monitoring at SLF level
- Submission of Monthly report by each SLF to concerned TLF within 3 days after SLF meeting by RP/CO
- Monitoring of repayment status of SV loans based on monthly reports submitted by SLFs
- Submission of Monthly report to Town Vending Committee within 3 days after TLF meeting by RP/ TMC
- The Town Vending Committee (TVC) should review the status of repayment of SV loans submitted by TLF/s every month and submit action taken report to the Town Level Bankers Committee (TLBC)
- 2. In this connection, it is decided to organize TVC meeting in all ULBs on 2nd Tuesday every month and TLBC meeting on 2nd Thursday of every month to review the monthly reports submitted by SLFs/TLFs in previous month meetings. In any case if the said dates are holidays, then the meetings should take place on next working day. The President of TLF should attend the TVC and TLBC meeting regularly.
- 3. Hence, the Commissioner, GHMC and MCs of all ULBs are hereby requested to organize meetings accordingly and upload the monthly reports in the CGG portal.

It is therefore requested to take necessary action in the matter.
