ORDER:

In the reference 1st cited, funds to a tune of Rs.1877.99 Lakhs (including State of Rs.469.50 Lakhs) were allocated for the Employment through Skill Training & Placement (EST&P) component of NULM. The target of 38400 has assigned to Telangana State. Among which, the target of 23400 with the placements of 11700 was fixed to MEPMA for EST&P program 2014-15.

Work Orders were released vide ref. 2nd cited, to 22 Skill Training Providers covering all NULM Towns in the State and the trainings are undergoing. Orders were issued to the DPMUs for the year 2014-15 to meet the expenditure towards inception payments to the STPs for the ongoing Trainings from the available funds of EST&P component.

As per the online report dt.23.03.2015, (7850) candidates have been registered under EST&P program for training in different courses in all NULM towns. The mobilization charges up to Rs.1000/- per candidate is to be released to DPMUs to meet the expenditure incurred towards mobilization and registration of candidates under EST&P.

Hence, you are requested to utilize the amount of Rs.78,50,000/- (Rs. Seventy eight lakhs Fifty thousand only) towards Mobilization expenses @ Rs.1000/- per candidate or actual expenditure, whichever is less, from the available funds with DPMUs. The ULB wise amount to be utilized is enclosed to this orders as Annexure.

The Project Directors, DPMUs are requested to utilize the funds as per the procedure and submit UCs. ^{Further} Not to divert/deviate the above amount for any purpose other than payment to Mobilization Charges including charges payable to CRPs and DEOs under EST&P program. Any deviation found, the matter will be viewed seriously as per CCC Rules.
