Implementation of USEP and UWSP Programmes for the Year 2013-14 was to be completed by 31-03-2014.

On perusal of the on-line data it is observed that grounding of units under USEP & UWSP is very low, though DPMUs have released subsidy to the Banks. Project Directors and field functionaries are not paying much attention in grounding of units by the banks inspite of repeated instructions from this office. Further during the District review meetings held at Hyderabad it is also brought to the notice that on-line data entry is pending. Therefore the Project Directors and DMCs are directed to persue the matter with the banks vigorously and see that all the sanctioned units under USEP and UWSP for which subsidy has been released to banks are grounded before the end of July 2014 at any cost and they are informed that on-line data entry screens for the year 2013-14 will be closed from 01-08-2014.

The said instructions should be followed scrupulously without any deviation and update the data entry immediately.
