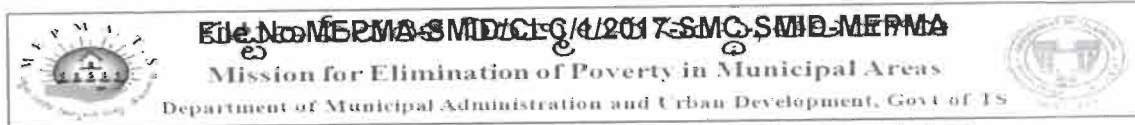

**Sub:-** MEPMA – SM &ID – City Livelihood Centre( CLCs) – Submission of proposal for establishment of one CLC building at Nirmal – Sanction of budget – 1<sup>st</sup> installment -Orders Issued .

**ORDER:**

Vide reference 1<sup>st</sup> cited, the GOI has given guidelines under NULM to establish City Livelihoods Centers (CLCs) in all ULBs of NULM towns. The concept of CLCs is to bridge the gap between demand and supply of the goods and services to the urban poor.

In this regard, Each CLC will be provided a non recurring grant of Rs. 10 Lakhs as untied funds and the amount will be released in 3 installments. The milestones for release of installments may be as follows

- 1<sup>st</sup> installment 30% released by SULM to ULB within one week of the proposal, sanction order is approved
- 2<sup>nd</sup> Installment 40% after the staff of CLC is recruited
- 3<sup>rd</sup> Installment 30% will be released offer launch of CLCs.

Vide reference 2<sup>nd</sup> cited, the proposals received from Nirmal ULB of Nirmal district of DAY- NULM town have been examined and recommended for the release of 1<sup>st</sup> Installment of 30% i.e an amount of Rs. 3,00,000/- to 1 City Livelihoods Center (CLC) in Nirmal district.

The details of the budget towards establishment of CLC in Nirmal district in of DAY- NULM towns are detailed below:
