The Principal Secretary (MA), MA & UD Department has directed to conduct survey and registration of street vendors in all ULBs by appending the survey format and format of identity card vide ref 1st cited along with further steps to be taken in all ULBs. Further vide ref 2nd cited, GoI has enacted the Legislation pertaining to Street Vending and vide ref 4th cited, the Govt has issued certain instructions for implementation of National Policy on urban Street Vendors.

It is to inform that vide ref. 5th cited all the PDs were instructed to facilitate formation of groups of street vendors duly communicating the district wise targets. An amount of Rs 26.00 lakhs was also released towards CRP strategy for survey, mobilization and formation of groups of Street vendors to all PDs.

In this connection, it is to inform that, in spite of several instructions issued from this office and reviews, the progress is very poor in GHMC, Medak, Nalgonda & Karimnagar as per the web information. Hence all the PDs are once again instructed to ensure that the progress is achieved by the end of Oct 2014. In case of issues in Bank A/c opening, concerned Banking specialists may be contacted for taking further necessary action.

PDs are also requested to issue necessary instructions to the LH &IB DMCs, so that they conduct orientation to CRPs by DRPs(LH &IB) for support in process of formation of groups of street vendors (CIG), deployment of CRPs (LH/IB) and other aspects to achieve the progress by the end of Nov 15th, 2014. CRPs services may be utilized to form CIGs is as follows:

1. One team consists of 2 CRPs (LH & IB)

2. 3 groups to be formed in 1 day(including Account opening).

3. Payment to CRPs may be as per the norms from NULM funds.

Therefore all the Project Directors are instructed to complete the formation of CIGs strictly following the timelines without fail.

- Establishing units in Self Employment Programme (SEP).
- Submission of UCs on survey and online data entry.
