The attention of all the Municipal Commissioners in the state is invited to the references cited, and it is to inform that instructions were issued to coordinate with bankers with more pendency of sanctions and disbursements of Street Vendor loans and organize bank/ Branch wise camps based on the requirement and sanction was also accorded for an amount of Rs. 1,500/- per Bank/ Branch wise camp towards Logistic Arrangements [Chairs, Tables, Tent (if required), etc), Drinking water, stationary, Misc etc.] vide reference 5<sup>th</sup> cited.

  - a. Sanction and disbursement of all the pending applications under PMSVANidhi and update in Udyamimitra Portal.
  - b. Generation of UPI IDs and issue of digital QR Codes to Street Vendors in the camps.
  - c. Training Street Vendors in digital transactions by using QR code and payment App/

- BHIM UPI App and financial literacy by utilizing the services of local bank branches and Digital Payment aggregators.
- d. Issue of RuPay debit card to the Street Vendors who don't have ATM card.
- e. Make the Street Vendors to undertake the penny drop transactions for both the processes Credit & Debit, to create evidence for handholding.
- 4. Hence, the Municipal Commissioners of all ULBs are hereby instructed to coordinate with bankers and organize bank/ branch wise camps based on the requirement and request from the bankers on the above said dates and ensure sanction, disbursement of all loans, Digital onboarding and training of all Street Vendors under PMSVANidhi Scheme. Additional camps may also be conducted on any other dates based on potential and request of the bankers. The camps conducted shall be submitted to the undersigned in the format enclosed for immediate release of grants.
