Through the ref. 3rd^t cited, the District wise targets and amount of credit/loan to be disbursed by the banks for 2016-17 are finalized and communicated along with the Timelines to be followed for implementation of Self Employment Programme (SEP) activities.

Through the ref. 4th cited, the ULB wise progress status reports have been received from Project Directors, which shows a large variation between the target and stage of progress shown.

You are aware that the 2nd quarter of 2016-17 will be completed by Sep, 2016 and a small number (658) of units have grounded under SEP against target of 4194 units. With regards to SHG-Bank Linkage, the achievement as on date is Rs.35768.37 lakhs against target of Rs.110689.56 lakhs. The Government is insisting for achievement of at least 60% financial target by 30.09.2016 and it is proposed to distribute the cheques under SEP and Bank Linkage on the occasion of Gandhi Jayanthi i.e. on 02.10.2016 by Hon'ble Minister for Municipal Administration

Further, you are directed to address Lead District Manager and Regional Managers of banks and appraise the issues to achieve the targets.

Hence, all the Project Directors of MEPMA in the state are directed to achieve at least 60% of the target in Self Employment Programme and SHG-Bank Linkage by 30th Sep, 2016 by assigning duties to all staff of DPMUs and MEPMA staff at ULB Level. Necessary action may be taken for distribution of loans under Self Employment Programme & Bank Linkage beneficiaries in the Gandhi Jayanthi Celebrations on 02-10-2016.
