With reference to the subject cited, it is to inform that all the MEPMA PDs were instructed for the positioning of PWD Volunteers through TLFs-duly following the guidelines 1st cited wherein it is mentioned that while positioning the PWD Volunteers through TLFs/Sr. SLFs-Preference shall be given to the community volunteers (CVs)/ Community Facilitators (CFs), who have already having sufficient experience in SHG/SLF strengthening.

In the reference 2nd cited, instruction have been issued in the G.O MS.no.265 for the utilize at least 40% of the net funds available with each Urban Local Bodies and for utilization of funds for developmental works of the Municipalities for various schemes on priority basis.

Further in view of the strengthening of SHGs/SLFs in Non-NULM towns it is decided to continue the services of Cluster Level Resources (CLRPs) & PWD volunteers for Disability interventions of Institutional Building

In this regard, reference 3rd cited Municipal Commissioners of Non NULM towns are requested to take necessary action to allocate the funds from Municipal General funds towards resource fees to Cluster Level Resource Persons (CLRPs) & PWD volunteers through Town Level Federations.



With ref 5th cited NULM has been extended to 72 ULBS of Telangana.
