I invite your attention to the references cited. Through the ref. 3rd cited, sanction was accorded to utilize the funds available with Project Directors, MEPMA in the state for release of 1st instalment (40%) Rs.90.19 lakh for construction/ Refurbishment of 15 Shelters for Urban Homeless in 11 NULM towns. Further, sanction was also accorded for utilization of funds Rs.90 lakh for Operation & Maintenance of temporary shelters operating in 11 NULM towns for one year, as per the directions of Hon'ble Supreme Court. Accordingly, funds were released to the concerned Municipal Commissioners for construction/ refurbishment of Shelters and maintenance of temporary shelters operated. Through the ref. 5th cited, you were requested to submit the progress report on construction/ refurbishment of Shelters and also on the O&M details for the running shelters. But so far, the progress report is not received from your end. You are well aware that the Hon'ble Supreme Court is critically observing the Shelters issue.

Hence, the Municipal Commissioners are requested to inspect and to submit a report on progress regarding construction/ refurbishment of Shelters and also on the Operation & Maintenance (O&M) details of running shelters in your jurisdiction immediately.
