**Sub:-** SM & ID - NULM- PWDs- Proposal for release of Sanction of Revolving Fund to SHGs OF PWD – NULM town – Reg.

**Ref:-** Operational guidelines of SM & ID dated:- 11.12.2013 from GOI.

\* \* \* \* \*

In the reference cited above, the guidelines of SM & ID component under NULM, as part of reducing social vulnerability, it is reiterated that NULM shall rest on the foundation that mobilization of Urban poor households to form their own institutions is an important investment for an effective and sustainable poverty Reduction Programmes. These institutions of the poor would partner with Govt. and Non Govt. Sector agencies to facilitate delivery of social and economic SHGs of handicapped persons would also be allowed to be formed.

Revolving fund support to Self Help Groups (SHGs) : Under NULM, the revolving fund is provided to the self Help Groups (SHGs) to inculcate the habit of thrift and credit, the revolving fund also builds institutional capacities of the SHGs in managing funds and forms the part of the corpus and can also be utilized towards internal lending,

One time Revolving Fund support of Rs. 10,000/- will be provided to each SHG.

The eligibility criteria for sanction of RF:

- SHG shall be formed with A/c being opened in its name and functional with minimum seniority of 6 months.
- RF is also available to the existing SHGs formed under SJSRY & the facilities have not been utilized earlier.
- As per NULM, SHG can route its application for sanction of RF through Resource Organizations i.e TLF.

In this connection, it is submitted that No.2481 of SHGs of PWDs are formed in Telangana State and out of which No.104 of PWD groups are formed since April.2014. The

above SHGs have not availed RF under SJSRY – as the same was not extended to PWD SHGs as PWD the guidelines under UWSP component (Urban Women Self Programme)

The following criteria may be adopted for routing the RF to SHGs of PWDs through TVSS, as per the guidelines of NULM.

PWD SHG, after fulfilling the requisite criteria like seniority, functioning status passes resolution for sanction of Revolving fund of Rs./- 10,000/- under NULM duly accepting for its proper utilization, prioritization ( insurance, food security and other purposes utilization, that the same will revolved amongst the members based on the prioritization ( insurance, food security and other purposes for which the member needs) without distributing equally.

- Submission of proposals to TVS for sanction.
- TVS, collects the eligible SHGs details and after assessing the performance and other criteria of SHG- place before TLFs for onward transmission to CMMU.
- CMMU/PD forwards the list of Eligible SHGs along with TLF resolution to MD, MEPMA.
- MD MEPMA releases to CMMU/PD
- CMMU , inturn releases directly to TLF A/Cs through single progs with copy marked to TLF
- TVS directly releases to the A/Cs of SHGs after passing resolution during its meeting and review its utilization during their regular meetings.
- No service charges or interest will be charged from SHGs.
- If any specific problem is faced regarding its utilization –TVS poses before TLF for resolving the same.

Hence, all the Project Directors, MEPMA and Municipal Commissioners are requested to submit the proposals RF to SHGs of PWDs by resolution from TLFs routed through TVS by 29<sup>th</sup> Oct -2014
